On the basis of the recommendations of the Board of Inspection and subsequent approval of Hon'ble Vice Chancellor, Rajasthan Technical University, Kota, Provisional affiliation is hereby granted to Arya institute of Engineering & Technolohy, Kukas, Jaipur for the courses and approved intake as per AICTE approval vide letter No. F.No.-06/04/RAJ/ENGG/2005/002 dated 21/06/2007 as detailed below subjected to fulfillment of the observations/deficiencies laid down by the Board of Inspection with in one month or earlier as mentioned below:

2.	To follow all the instructions issued from time to time by the University and to furnish all the information and statistics desired by the University.		
3	Staff: Appointment of permanent and qualified Principal and teaching staff on full time basis selected by a duly constituted selection commit as per AICTE norms.		
4	Building: Construction of sufficient building as per guidelines of the AICTE, play grounds and hostel building.		
5	Library: Year wise development of college Library and provision of funds for journals and magazines be made.		
6	Endowment Fund: Endowment fund as prescribed under the statute 26(8) and regulations there under page 226 of Hand Book of University of Rajasthan, Jaipur Volume I Part-II (as adopted by Rajasthan Technical University, Kota) is to be created, if not created so far.		
7	As being a registered Society/Trust, the periodical elections for various posts enunciated in the constitution therein must be ensured with transparency.		
8	In exercising the provisions under Statute-26(2) of Rajasthan Technical University, Kota Act, 2006 the University shall appoint its representative in the governing body of the college/Institute. Proceedings of all the meetings should be ensured under his presence. If the representative is unable to attend such meeting, the minutes shall be forwarded to him/her and comments may be solicited within 7 days after adjournment of the meeting.

Observations laid down by Inspection Team and subsequently by Board of Inspection

- 1- The Selection proceedings of duly constituted selection committee appointment letters, joining reports, salary details & bio-data of faculty(except principal) not submitted.
- 2- The No .of library books & titles are inadequate considering AICTE norms.
- 3- Only 04 journals are being subscribed by the institute.
- 4- MBA programme is extension of Engineering programme. The computer lab is not exclusive for MBA programme, it is being time shared with Engineering students.
- 5- The institute should sort out the above inadequacies recommended for extension of affiliation.

Observations laid down by Sub Committee and subsequently by Board of Inspection

- 1- The selection proceeding of duly constituted selection committee, appointment letters, joining reports, salary details & Bio-data of faculty (except principal) not submitted.
- 2- The number of library books & titles are inadequate considering AICTE norms.
- 3- Only a few journals are being subscribed by the Institute. There shortfall of 10 reputed National and one International Journals.
- 4- MBA Programme is extension of Engineering Programme. The Computer lab is not exclusive for MBA Programme, it is being time shared wit<sup>1</sup> Engineering students.

It will be extremely difficult to grant the affiliation for next session i.e. 2008-09 it conditions/deficiencies furnished above are not fulfilled within in stipulated time.
